GIVING UNDER A DEED OF COVENANT IS SIMPLE, CONVENIENT AND VERY EFFECTIVE

By signing a deed of covenant, you commit to giving a regular amount to the Church on a weekly, monthly, quarterly or annual basis for a minimum period of five years.

At the end of each tax year (ie 31st December), you will be sent a tax certificate to sign, confirming the amount you have given to the Church. This certificate must be returned to the Covenants Administrator, who will submit the form to the Comptroller of Taxes in order to claim the tax element of your donation.

The amount recoverable equates to 25% of the amount you actually give so, for example, for every £100 you donate, a further £25 is received from the Comptroller and the Church therefore actually receives a total of £125.

Please would you complete and return the Deed of Covenant Form to the Covenants Administrator. If you wish to set up a standing order with your bank, please also complete the attached form and send it directly to your bank (alternatively, you may set up an automated payment directly with your bank). If you do set up a standing order, please would you advise the Covenants Administrator accordingly.

- 1) Please do not complete a deed of covenant form if you do not pay Jersey Income Tax.
- 2) If your circumstances change after you have completed a deed of covenant and either you can no longer afford to pay the covenant, or alternatively you have moved to a different church, the covenant can be cancelled. Please contact the Covenant Administrator.
- 3) If you do not wish to commit to giving regularly, you may alternatively wish to consider giving occasional lumps sums. Tax is now recoverable on any donation over £50.
